

Process Map for COVID-19

Individual reports they are POSITIVE for COVID-19 OR Individual reports one or more symptoms* BEFORE entry to the building.	Individual reports experiencing one or more symptoms* of COVID-19 during the school day.	Individual reports being in "close contact" with someone who has tested positive. Step 1: Individual must self-isolate and may return when the Return to School Criteria has been met. See below. If the individual has an immediate family member in the same household who attends or is employed by TeSA or FWafa, he/she must also remain home until the reporting individual meets the Return to School Criteria.	Step 1: Individual remains home and self-isolates for 14 days. Return Date _____	Step 1: Individual may return when the someone at home receives an alternate diagnosis OR has two negative tests at least 24 hours apart.	If the someone at home is not symptomatic, but just 'exposed,' individual may come to school.

Step 2: School determines if other students or staff were in " close contact " with individual. Close Contact - Defined as "being directly exposed to infectious secretions (e.g. being coughed on while not wearing a mask); OR being within 6 feet for a cumulative duration of 15 minutes or more over a 24-hour period starting from 2 days before illness onset (or for asymptomatic patients, 2 days prior to test specimen collection) until the patient is isolated.	Step 2: No determination of close contact nor notification to other students and staff is made.

Step 2A: If it is determined there was no " close contact ," no further action is taken.	Step 2B: If it is determined there was " close contact ," the campus principal will send written notification of possible exposure to all staff and families of students who were exposed. Students and staff who were in " close contact " will be asked to self-quarantine for 14 days.

	New uncontrolled cough that causes difficulty breathing (students with chronic allergic/asthmatic cough, a change in cough from usual)		Significant muscle pain or body aches

	Severe headache		Nausea or vomiting

Return to School Criteria **Return Date:** _____

The student may return to school when the following three criteria have been met:

1. At least 24 hours have passed since recovery (resolution of fever without the use of fever-reducing medications);
2. The individual has improvement in symptoms (e.g. cough, shortness of breath);
3. At least 10 days have passed since symptoms first appeared.

If the student wants to return to school before the above criteria are met, the student must either

- (a) Obtain a medical professional's note clearing the student for return based on an alternative diagnosis **OR**
- (b) Receive two separate confirmations at least 24 hours apart that they are free of COVID via accurate infection tests at an approved COVID-19 testing location.
