

CONFLICT OF INTEREST POLICY

Every director or officer of Texas Center for Arts+ Academics (TCA+A) shall avoid any conflict between his/her personal, professional, or business interests and the interests of TCA+A in all actions taken by or on behalf of TCA+A.

At the beginning of each fiscal year, every director or officer of TCA+A shall sign a conflict-of-interest statement that will be kept on file with TCA+A records.

No director or officer shall use his or her position, or the knowledge gained therefrom, in such a manner that a conflict between the interest of TCA+A and his or her personal or business interests arises, and each such person has a duty to place the interest of TCA+A foremost in any dealings with TCA+A.

If any director or officer of TCA+A has any direct or indirect interest in, or relationship to, any individual or organization that proposes to enter into a transaction with TCA+A, such person shall:

- Provide prompt written notice of such interest or relationship to the Board of Directors of TCA+A;
- Refrain from participating in any discussion or voting on that particular transaction;
 and
- Not attempt to exert any influence on TCA+A to affect the outcome of the decision-making process.

A director or officer shall not use any information received while serving TCA+A in such a manner that the use of such information would be detrimental in any way to TCA+A. Any actions that might impair the reputation of TCA+A must also be avoided.
